### PHOTO CONTEST RULES:

- 1. Submissions:** All entries must be submitted to [PhotoContest@citizenswv.com](mailto:PhotoContest@citizenswv.com). We will not accept any photos that are printed or contained on any portable media device (CDs, flash drives, etc.)
- 2. Photo Format:** Horizontal orientation only. JPG or PNG format only.
- 3. Photo Size & Resolution:** Not less than 10 megapixels or 300 dpi.
- 4. Age:** You must be at least 18 years of age to enter.
- 5. Timeline:** Photos must be submitted before August 31, 2017.
- 6. Winners & Prizes:** Twelve, \$50 prizes will be awarded along with one, \$100 prize for the cover photo. Winners will be notified in September.
- 7. Entry Information:** Each photo must identify the photographer's name, address, phone number, email address and brief description of where and when the photograph was taken. Your entry may be disqualified if you fail to provide this information.
- 8. No Persons may appear in the photo.**
